


# **Covered parking for growing fleet**

As the District's fleet increases, it has become imperative to provide additional covered parking for vehicles and equipment. Last year the District procured two metal buildings, one 40'x25'x15 and the other 60'x25'x15. Staff recently completed construction of these buildings. LED lighting was added to these buildings for safety and security. The lights come on with the street lights at night and continue during the early morning hours. The additional parking space has allowed vehicles to be relocated from the wash bay and lube bay, creating more workable space for staff.

# **Implemented Safety Suggestions**

As part of the District's Safety Program, employees are encouraged to identify safety hazards and submit safety suggestions to the Safety Team. The Safety Team reviews these suggestions and sends them to management for approval. Once approved, suggestions are relayed to the applicable department to remedy the concern. Recently, the Maintenance department has addressed two suggestions: a slip hazard caused by water from the sample tap freezing over a vault, and a difficult-to-open hatch that is used daily. To prevent the slip hazard, staff relocated the sample tap to be flush into a gravel drainage area. To remedy the difficult hatch at 10MG reservoir, the hatch was removed completely and in its place a walk-in building with a door was constructed. A big thank you to everyone involved with these projects that make the District a safer place to work.

# Turbidimeter at SLA intake

District staff installed a turbidimeter at the Salt Lake Aqueduct intake to monitor water quality at the dam. The increased turbidity stems from ongoing construction related to the Deer Creek Intake project. For the past three week ago, the turbidimeter has provided Operations staff as well as Provo River Water Users Association staff with water quality information at the dam. Any concerns have been communicated to the contractors via Association staff.

District staff recently attended the AWWA Intermountain Section Conference in Layton, UT. District operator Rikely Gonzales presented on troubleshooting a filter at the Little Cottonwood Water Treatment Plant. While conducting a filter media evaluation project, a mound of media was found in one of the filters. The filter was cleaned and used for a backwash to test, but the mound reappeared. When inspected again, a piece of caution tape was found wrapped on the nozzle. The tape was remove and when tested again, no mound of media reappeared. The filter was disinfected and cleaned, samples where tested by the Lab and there have been no further issues.
